# KISSING THE BRIDE



## ENTIRE AGREEMENT:

This agreement contains the entire understanding between **KISSING THE BRIDE** and **THE CLIENT**. It supersedes all prior and simultaneous agreements between the parties. The only way to change or add to this agreement is to do so in writing. These changes need to be signed by all relevant parties.

## RETAINER:

Upon your booking fee, **KISSING THE BRIDE** will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, a retainer of £250 is non-refundable, even if the date is changed or the wedding cancelled for any reason; including acts of God, fire, strike and/or extreme weather. The retainer is to be paid at time of signing the contract. The retainer is applied towards the contracted wedding photography package. **THE CLIENT** understands and agrees that the entire amount owed for the wedding photography package described in the contract is due **7 (SEVEN) DAYS** prior to the wedding date.

## PICTURE DELIVERY:

**KISSING THE BRIDE** will provide **THE CLIENT** with a high-resolution download link. This link will contain photographs taken during your special day and edited by the photographer. (COPY RIGHT HANDED OVER TO CLIENT)

## CANCELLATION:

In the event that **THE CLIENT** cancels the contracted services for wedding photography outlined in this contract before the wedding ceremony takes place, the retainer will be forfeited. **KISSING THE BRIDE** agrees to refund all additional paid money (less expenditures for which receipts will be provided), to **THE CLIENT**.

## EVENT GUIDE:

**THE CLIENT** will be responsible for (or have someone designated for this responsibility) identifying people/objects of whom/which specific photographs are desired. The photographer will NOT be held accountable for not photographing desired people if there is no one to assist in identifying or gathering people for the photograph(s). **THE CLIENT** is also responsible for identifying any individual/s that do not desire to be photographed.

## 90 MINUTE WINDOW:

**THE BRIDE & GROOM** Allow at least 90 minutes (minimum) time frame afterward for photographs that cannot be obtained during the ceremony or reception. The 90 minutes following the ceremony includes group photographs if required and bride & groom pictures. If either the bride's or groom's late arrival (or any other reason outside of the photographer's control) prevents this 90 minute window from occurring, **KISSING THE BRIDE** shall not be held liable for failure to take desired photographs.

## CO-OPERATION:

The parties agree to positive cooperation and communication for the best possible result within the definition of this assignment. **KISSING THE BRIDE** is not responsible for key individuals' failure to be present or to cooperate during photography sessions, neither for missed images due to details not revealed to **KISSING THE BRIDE**. **KISSING THE BRIDE** recommends that **THE CLIENT** designate an "event guide" to point out important individuals to the photographer, whom **THE CLIENT** wishes to include in informal or candid photographs.

## SHOOTING TIME / ADDITIONS:

The photography schedule and selected methodology are designed to accomplish the goals and wishes of **THE CLIENT** in a manner enjoyed by all parties involved. **THE CLIENT** and **KISSING THE BRIDE** agree that positive co-operation and punctuality are therefore essential. Shooting commences at the scheduled time. Should the ceremony start late due to any reason whatsoever; **KISSING THE BRIDE** will not be held liable for any photographs not taken.

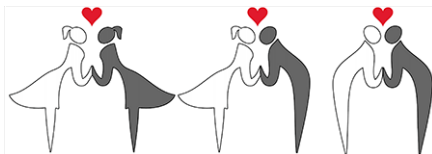
## HOUSE RULES:

The guidelines of the ceremony, official, or the reception site management limits the photographer. **THE CLIENT** agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is **THE CLIENT'S** responsibility. **KISSING THE BRIDE** will offer technical recommendations only.

## DIGITAL NEGATIVES & COPYRIGHTS:

The photographs, digital negatives or prints produced by **KISSING THE BRIDE** are protected by Copyright Law (all rights reserved) and may not be reproduced in any manner without **KISSING THE BRIDE** explicit written permission, a download link will be provided to.

# KISSING THE BRIDE



## MODEL RELEASE:

**THE CLIENT** hereby assigns and grants **KISSING THE BRIDE** and its legal representatives the irrevocable and unrestricted right to use and publish photographs of **THE CLIENT** or in which **THE CLIENT** may be included, for editorial, trade, advertising or any other purpose and in any manner and medium; to alter the same without restriction; and to copyright the same. **THE CLIENT** hereby releases **KISSING THE BRIDE** and its legal representatives and assigns from all claims and liability relating to said photographs. It is agreed that **KISSING THE BRIDE** may display and use the photographs taken for advertising, display, website and internet promotion, photographic contests, public display such as in malls, photography books, photography instructional books, store fronts, window displays, studio display, television advertising, magazine advertising and any other purpose thought proper by **KISSING THE BRIDE**

## EXCLUSIVITY / GUEST PHOTOGRAPHY:

It is understood that **KISSING THE BRIDE** will act as the sole and exclusive wedding photographer. Because of the fact that flashes from guest's cameras may ruin shots taken by **KISSING THE BRIDE**, **THE CLIENT** acknowledges that **KISSING THE BRIDE** will not be held liable for any shots unavailable because of interference from guest photography.

## GUEST COOPERATION:

**THE CLIENT** is responsible for the conduct of their guests. **THE CLIENT** will direct all other service providers (florist, DJ, caterer, etc.) to provide any needed information and co-operation to the photographer. Co-ordination with other service providers is necessary to complete all the photography sessions as scheduled. **THE CLIENT** should share the photography schedule with other service providers to make sure that there is no conflict in times. In addition, events during the wedding day should be planned to make the best use of time from all vendors.

**KISSING THE BRIDE** will not tolerate verbally or physically abusive behaviour, nor will it share its time or compete with guest photographers for the attention of the subjects. Unchecked guest conduct that interferes with photography may seriously affect the quality of the photographs taken and increase the number of times photos must be re-taken. If **THE CLIENT** is unable to control the conduct of their guests, resulting in an unacceptable degree of misconduct, or if the conduct of any of their guests damages the equipment of the photographer, it will result in the early or immediate departure of the photographer. **THE CLIENT** understands that in such an event, no refunds will be granted and any damage to equipment will be the responsibility of **THE CLIENT** to replace or repair.

## COMPLETION SCHEDULE:

Digital processing takes approximately 2 weeks. Creation of a wedding album takes 4-6 weeks, enlargements 1-2 weeks or possibly longer when laboratory and bindery schedules are heavy. (APPLICABLE IF CLIENTS REQUIRE PRINTS OR ALBUMS)

## PAYMENTS:

**THE CLIENT** agrees that £250 retainer is required at the time of contract acceptance and 100% of the remaining balance is due 7 days prior to the wedding date.

## PENALTY FEES & CHARGES:

There is a £50.00 late payment fee for any payments that are not postmarked or delivered to **KISSING THE BRIDE** by the required date. **THE CLIENT** IS RESPONSIBLE FOR ALL REASONABLE SOLICITORS FEES AND COSTS OF COLLECTION.

## RIGHT OF WITHDRAWAL:

**KISSING THE BRIDE** discovery of new information changes to agreed circumstances, or other factor, which tends to circumvent its policies, may result in its withdrawal. Non-cooperation; changes in locations, facilities or available times; missed appointments and late payments are examples of contributing factors. Should **KISSING THE BRIDE** initiate the withdrawal, all fees will be returned, excluding retainer as well as fair market value for all services/products already provided. In case of withdrawal, £75.00 an hour is charged for all photography services already provided and £50.00 an hour is charged for all other services, consultations and all driving time, rounded up to the nearest half-hour.

## LIMIT OF LIABILITY:

In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. **KISSING THE BRIDE** will make every effort to secure a replacement photographer able and/or willing to provide a similar package as chosen in this contract at the same/similar tariff. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package.

# KISSING THE BRIDE



**KISSING THE BRIDE** Uses professional grade equipment and professional grade backup equipment. However, in the unlikely event of **THE CLIENT'S** photographs being lost, stolen or destroyed for reasons within or beyond **KISSING THE BRIDE** control, the latter's liability is limited to the return of all payments received for the event package. The limit of liability shall not exceed the contract price stated herein. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.

#### NON-GUARANTEE:

Although every possible care will be taken to produce photographs of all important and special events during the wedding, **KISSING THE BRIDE** cannot place an unconditional guarantee on the above. **KISSING THE BRIDE** will not be held responsible for any ruined photographs due to guests' (or any other) flashes; or any other ruined photographs due to any other cause in or outside of **KISSING THE BRIDE** control.

#### PERFORMANCE:

The performance of this contract on behalf of **KISSING THE BRIDE** shall be contingent upon acts of God, flood, fire, warfare, government laws or regulations, electrical failure, strikes by suppliers, and/or conditions beyond its control.

#### SEVER ABILITY:

If any provision of this agreement is held to be invalid or unenforceable under the law, the validity of this agreement as a whole shall not be affected, and the other provisions of the agreement shall remain in full force and effect.

#### AMENDMENTS:

This contract has been freely negotiated and shall be recognised as the entirety of the agreement. Only those changes or modifications specifically placed in writing, attached, dated and signed by **THE CLIENT** and **KISSING THE BRIDE** at the time of acceptance of this contract shall be recognised as amendments to this contract.

#### PRICE GUARANTEE:

The prices listed in this contract expire one year after the wedding date and orders placed after this time has expired will be at current **KISSING THE BRIDE** rates.

Additional Hours: £50.00 per hour **UNLESS WAVERED BY KISSING THE BRIDE**

Please note that these prices are only good for 60 days following the wedding, after that they are subject to change without any prior notice. I have read and understood the terms above. I hereby agree to the terms of this agreement.
